#### SUMMARY OF MONITORING COMMITTEE DECISIONS

In summary, the Monitoring Committee is not referenced in our Rules of Procedure and is not a formal part of the Governance Structure included in the Convention Text. It was established by a COP Decision with a specific mandate and TORs. Those were reviewed and/or updated over the years depending on the needs of the Parties. During the early years of the Convention, there were joint face to face meetings of the "Bureau and Monitoring Committee" in preparation for the IGM/Cartagena Convention COP (usually the year before). In those days, there were also no ISTACS, STACs, or Protocol Conferences of Parties as these instruments had not yet entered into force.

There were a total of thirteen (13) meetings of this grouping with the last one taking place in 2003. There was an agreement in 2004 by Contracting Parties that given the financial challenges and given that the Secretariat had increased costs to convene 2 STACs, 2 Protocol COPs and an IGM/Cartagena Convention COP, that there was no longer a need for face to face meetings of the Bureau and Monitoring Committee. However, every COP, members of the Monitoring Committee continue to be elected in the event they are needed at any time by the Contracting Parties for a specific task.

The secretariat proposed to not schedule the next Meeting of the Monitoring Committee during the 2004-2005 biennium in order to save funds and allow the secretariat to dedicate its energy to the execution of the approved workplan. This proposal was approved by the Meeting.
