The procedures for the establishment of the list of protected areas are outlined in Article 7 of the SPAW Protocol.

Parties are expected to take the necessary measures to protect, preserve and sustainably manage "areas that require protection to safeguard their special value."

Areas proposed must have in place legal, institutional & management frameworks for the protection and conservation of their natural features.

Purpose of Listing

To identify areas of importance to the Wider Caribbean region (WCR) to be given priority

- for scientific and technical research
- for mutual assistance and
- to protect the listed areas from activities that would undermine the purposes for which they were listed

Benefits

- Protect/preserve areas, habitats & species with special ecological, cultural & socio-economic values
- Prevent species from becoming endangered or threatened
- Provides for the special needs of threatened/endangered/endemic/ migratory species - in particular species in Annexes I, II & III
- Enhance recognition and visibility of the listed site
- Raise awareness of site's importance regionally
- Gives priority status for SPAW support

Establishment of Protected Areas (Article 4)

"Areas are established for protection with a view to sustaining the natural resources of the WCR, and encouraging ecologically sound and appropriate use, understanding and enjoyment of these areas, in accordance with the objectives and characteristics of each of them."

(e.g areas of special biological, ecological, educational, scientific, historic, cultural, recreational, archaeological, aesthetic, or economic value)

A Cooperation Programme has been designed to achieve eco-regional strategic conservation and sustainable management of the marine resources while increasing capacity and promoting cooperation among listed areas.

Regional Database of Marine Protected Areas

The Protected Areas will together form a network, which will

- contribute to the effective conservation of the natural heritage of the Caribbean.
- be used as a tool to promote regional & international cooperation in relation to complementary environmental treaties, consistent with the SPAW criteria and listing process.
- comprise a comprehensive & representative system of protected areas in the WCR, across all bioregions/across the range of ecosystems within each bioregion.
