Status of Ratification of the LBS Protocol

Decision 17 refers to the Secretariat's efforts to:

"encourage all Non-Contracting Parties to the LBS Protocol to become Contracting Parties at their earliest opportunity, and in doing so, the Secretariat should provide Non-Contracting Parties with examples of benefits of ratification including through the achievements of Contracting Parties in addressing marine pollution from land-based sources and activities"

- 1. Pursuant to Decision 17 as quoted above of the Fifth Meeting of the Contracting Parties(COP) to the Protocol Concerning Pollution from Land-Based Sources and Activities (LBS) in the Wider Caribbean Region, 26 July 2021. The Secretariat to the Cartagena Convention convened two virtual meetings in English and Spanish for Non-Contracting parties to the LBS Protocol in November 2021 to promote ratification, assess the level of progress in the ratification of the LBS Protocol, identify major barriers to ratification and the type of support that could be provided by the Cartagena Convention Secretariat, the LBS Regional Activity Centres (RACs) and Regional Activity Networks (RANs), through ongoing programmes, projects, and activities (UNEP (DEPI)/CAR WG.44/INF.4).
- 2. During the workshop participants were invited to input their responses to 3 questions regarding opportunities and barriers to ratification within their country and key stakeholders to engage. The questions and responses are noted in the tables below:

3. The Governments of Guatemala, Mexico, Suriname and Saint Kitts and Nevis were provided with technical support and advice to assist them with becoming Parties to the LBS Protocol. As a result of this support, Saint Kitts and Nevis prepared and submitted a request to its Cabinet of Ministers for ratification of the LBS Protocol. The request was approved, and efforts are underway to formally deposit the instrument of ratification.
