Progress Report: ACP MEA III Project Small Scale Funding Agreement with the Gulf and Caribbean Fisheries Institute

### Activity 1: Develop a set of criteria in collaboration with the Cartagena Convention Secretariat for the implementation of the small grants

### a) Launch of grants programme

The Gulf and Caribbean Fisheries Institute (GCFI) through its MPAConnect and GPML-Caribe Initiatives supported the development of criteria for a small grants programme In partnership with the Cartagena Convention Secretariat. Through this interactive progress, Calls for Proposals were developed and advertised by MPAConnect in support of capacity building at site-specific marine protected areas (MPA) within the Wider Caribbean Region and also by GPML-Caribe in support of marine litter prevention and reduction within the Wider Caribbean Region. MPAConnect offered grants of up to US\$8,000 in support of capacity building at site-specific marine protected areas whilst GPML-Caribe offered grants of up to US\$15,000 in support of marine litter prevention and reduction. Hybrid grants of up to US\$20,000 were offered to support marine litter prevention and reduction work in marine protected areas in the Wider Caribbean Region.

### b) Advertise for proposals

The Calls for Proposals were distributed by GCFI, the Cartagena Convention Secretariat and other relevant partners. Email distribution lists (e.g. GCFI-Net and GPML-Caribe) and social media platforms (e.g. Facebook, Instagram and Twitter) were also utilized. An in depth PDF containing eligibility criteria, funding priorities, funding information and the proposal format was distributed with visually attractive graphics (See Annex 1.1). This content was first advertised on July 5th, 2022 with a deadline extension to August 10, 2022.

### c) Selection of Grants

A total of 26 proposals were submitted with 15 proposals being shortlisted and 9 proposals being selected for funding (See Appendix 1.2). GCFI together with the Cartagena Convention Secretariat reviewed proposals and participated in interviews with shortlisted proposals for ultimate selection of funded proposals.

# GPML-Caribe Small Grants Fund

GPML-Caribe, a partnership between the Gulf and Caribbean Fisheries Institute (GCFI) and the UNEP Cartagena Convention Secretariat, is pleased to offer small grants in support of marine litter prevention and reduction within the Wider Caribbean Region. The grants will be administered by GPML-Caribe with funding provided by the United Nations Environment Programme – Cartagena Convention Secretariat through the European Union's ACP MEA III project. The ACP MEAs program is a joint partnership between the European Union, the Organization of African, Caribbean and Pacific States, UN Environment Programme and the Food and Agriculture Organization of the United Nations which aims at building capacity in 79 countries in Africa, Caribbean and the Pacific (ACP) to support them in fulfilling their obligations as parties to Multilateral Environmental Agreements (MEAs) to tackle the environmental issues they face.

Eligibility Criteria: This call is intended to benefit the managing organizations of marine litter issues within the Wider Caribbean Region, either directly or through efforts with their affiliated partners. The call excludes U.S. affiliated sites and in rare instances final consideration for funding may be dependent upon satisfying the requirements of the U.S. Treasury Department's Office of Foreign Asset Control. Proposals from LBS Protocol Contracting Parties will be prioritized, though proposals from other countries within the Wider Caribbean Region will be considered.

**Funding Priorities**: Preference will be given to projects or approaches that are solutions-based. Research projects will be considered if they have a strong focus on solutions including an implementation phase. Potential projects focused on marine litter (including ALDFG) may include: Identification and removal approaches; Communications targeted to all stakeholders; Governance and policy-related solutions; Education-focused projects; Innovative community-based solutions; Innovative approaches for alternatives to single-use plastics and Styrofoam; Market-based approaches; Circular economy approaches; Reduction at source approaches; Development and/or implementation of local, national, or regional litter prevention/reduction plans.

Consideration will be given to projects that focus on youth, indigenous people, vulnerable communities, and gender-based solutions

If your project addresses marine protected areas, a proposal may be submitted as part of our call for proposals on marine protected areas. Guidelines for that call may be found here.

**Funding Information:** Budget requests should not exceed US\$15,000. Up to 50:50 counterpart funding should be provided. Matched funding must be from a non-federal U.S. source and can include in-kind contributions.

**Deadline for Applications:** Project proposals, based on the template provided, should be submitted by **August 10, 2022**. Shortlisted candidates will be contacted by August 17, 2022 to schedule meetings to discuss the activities outlined in the concept note.

**Project Duration:** The maximum duration of submitted projects is 9 months. Approved projects will be notified by September 1, 2022, with projects commencing approximately in October.

Eligibility criterio: This call is intended to benefit the managing organizations of MPAs within the selected countries, either directly or through efforts with their affiliated partners. The call excludes U.S. affiliated sites and in rare instances final consideration for funding may be dependent upon satisfying the requirements of the U.S. Treasury Department's Office of Foreign Asset Control. Projects submitted by eligible government agencies that manage MPA member sites must be implemented by non-government organizations / affiliated partners within the member country.

Proposals from <u>SPAW Priority MPAs</u> will be prioritized, though proposals from other Caribbean MPAs will be considered.

Funding priorities: Competitive applications should respond to the site's highest priority MPA management capacity building needs. For example, this may include sustainable financing, enforcement, communications, management effectiveness, response to stony coral tissue loss disease, or other high priority management capacity building needs.

If your project addresses marine pollution a proposal may be submitted as part of our call for proposals on marine litter. Guidelines for that call may be found here.

Funding information: Budget requests should not exceed US\$8,000. Up to 50:50 counterpart funding should be provided. Matched funding must be from a non-federal U.S. source and can include in-kind contributions.

Deadline for applications: Project proposals, based on the template provided, should be submitted by **August 1**, **2022**. Shortlisted candidates will be contacted by August 15, 2022 to schedule meetings to discuss the activities outlined in the concept note.

### Activity 2: Facilitate community-based Marine Litter and Marine Protected Areas Projects under the ACP MEA III Work plan

a) Implement all aspects of a small grants program in support of marine litter prevention and reduction(consisting of at least 3 small grants) Output 2.3.6 ACP MEAs III.

Through this small grant programme, 3 marine litter and 3 hybrid community based projects with a focus on plastic reduction, reuse and recycling were awarded with funding in September 2022. All work is currently ongoing and is expected to be completed as scheduled.

b) Implement all aspects of a small grants program in support of effective marine protected areamanagement (consisting of at least 5 small grants for example on MPA management effectiveness, capacity assessments and other management priorities) Output 2.2.4 and 2.2.5 ACP MEAs III.

Currently three small grants supporting management capacity building for the implementation of effective MPAs, and hybrid grants in support of marine litter management are in implementation. Additional MPA management small grant proposals are in development with technical support from the MPAConnect team.

c) Develop MPA management capacity building material in collaboration with the MPAConnect network and SPAW RAC MPAs working group, share materials and promote peer-to-peer networking among MPAmanagers. Compile financial and technical reports from different small grants • Prepare interim progress report for presentation at the 6th LBS STAC and 10th SPAW STAC

Management capacity building materials will feature lessons learned by SPAW priority MPAs participating in the MPAConnect network. The following MPA case study sites have been identified:

- Port Honduras Marine Reserve, Belize
- Moliniere/Beausejour Marine Protected Area, Grenada
- Sint Eustatius Marine National Park, Dutch Caribbean
- Saba Bank National Park, Dutch Caribbean
- Saba Marine National Park, Dutch Caribbean
- Tobago Cays Marine Park, St. Vincent and the Grenadines

Lessons on MPA management capacity from these sites will come from updated MPAConnect management capacity assessments compared with past findings from capacity assessments in 2011 and 2017. MPAConnect's coordination team recruited an assessment team that includes four members with experience from past assessments and three mentor MPA managers. The MPAConnect Coordinator (E. Doyle) with Coordination Team Member D. Wusinich-Mendez (NOAA) hosted a remote training session for the assessment team. During this session, the team was briefed in the use of the assessment tool. Following several work planning sessions, a schedule has been developed for team members to conduct management capacity assessment interviews with MPA management staff at the target sites beginning in early 2023.

To date, this work has been co-funded through support from NOAA's Coral Reef Conservation Program and USAID. Staff costs as per the original budget are programmed for expenditure in early 2023.
